JOB SUMMARY:

The primary focus of the position is to assist families who have children with an intellectual disability explore residential options in their communities. This includes identifying the resources and supports needed and facilitating development and implementation of individualized plans and budget. The Senior Facilitator - LIGHTS will provide support to the Advisory Group and act as staff liaison for CL Toronto.

RESPONSIBILITIES:

Reporting to the Regional Executive Director, responsibilities include:

- Ongoing co-ordination, communication and marketing of LIGHTS.
- Responding to general inquiries and intakes and applying criteria to determine a family's eligibility for LIGHTS
- Facilitating family networking using a variety of methods such as meetings, information sessions, e-mail and website based activities.
- Determining level and types of supports available to those families who are eligible for LIGHTS in partnership with the Advisory Group.
- Assisting families to co-ordinate the supports required to put together their residential plans. The Facilitator will work closely with a resource team within CL Toronto who will help families with their plans and required budgets.
- Developing tools to evaluate success, and making the necessary adaptations to ensure the vitality of LIGHTS.
- Administering, moderating and updating the LIGHTS virtual site which will be housed in the "Connected Families" part of ConnectABILITY.ca. This will include information updating, "matching" components, live chats, discussion boards and monitoring all LIGHTS content on the site.
